Brilliance is readily soluble in water and can be applied with conventional application equipment. Apply Brilliance early in the season prior to the onset of stress. Do not apply Brilliance to turf under stress. One full-rate application (or 2 split applications) of Brilliance will provide up to 3 to 4 months of relief from water repellency problems such as LDS. The number of applications required is directly related to the length of the growing season, environmental and geographic conditions. Consult with your sales representative for the specific recommendation in your geographic location.
