	Apply Rewet at above rates weekly until turf conditions improve; then begin monthly treatment, or apply as needed, at the above rates. Irrigate sufficiently to remove from leaf surfaces.			
Following Topdress Applications	5-8 Fl. Oz.	1 Gal of Water	160-260 mLs	4 L of Water
	To treat areas following topdress applications, apply Rewet at above rates. Re-apply at above rates on a weekly basis as needed. Irrigate sufficiently after each application to remove Rewet from leaf surfaces.			
Sodding	5-8 Fl. Oz.	1 Gal of Water	160-260 mLs	4 L of Water
	Apply Rewet at above rates to newly laid sod. Irrigate well to distribute Rewet throughout the rootzone, and to remove Rewet from leaf surfaces.
